

Hello Freedom Hunt hunters and volunteers!

Please find enclosed an Application and other pertinent information related to the 2017 Freedom Hunt Deer Hunt. The 2017 Freedom Hunt will take place between September 22<sup>rd</sup> -- September 24<sup>th</sup>. If you recall, the youth season age limit was recently increased allowing any hunters age 17 and under to participate in the Indiana Deer Youth season. Therefore, Freedom Hunt is accepting applications from any hunter who is 17 years of age or younger prior to September 22<sup>rd</sup>, 2017.

Enclosed, you will find all the documentation necessary to secure your spot in the 2017 Freedom Hunt deer hunt. It is imperative that you complete your application immediately and return it to us as soon as practically possible. It is also imperative that your guest(s) complete the enclosed *Guest Consent and Waiver Form* and return it with your application to the address listed below.

As Freedom Hunt continues to grow, we are constantly reviewing our policies with respect to camp and hunting rules and regulations. Due to the increase in popularity of the hunt, we have decided to limit the number of guests per hunter. *All participants will be limited to three guests* in camp with them until Sunday afternoon. The same rule applies to camp volunteers. However, after noon on Sunday, we will welcome anyone into camp for our closing ceremonies and the door prize give away. We would specifically note that children are not to be left unattended at camp, including volunteers who leave the camp for any reason during the weekend.

Again, it is important that you review all the enclosed documentation. We are trying to eliminate the necessity of completing information at the gate before the hunt. All hunters and volunteers must complete the appropriate forms and return them to us ASAP! *Because of the growing popularity, it is possible that we may not have room for all applicants and therefore, your application should be submitted immediately.*
